Identification Check

You must provide at 100 points of identification with your application. Note: at least one form of photo identification must be provided.

40 points – drivers licence, passport, birth certificate 30 points – 18+ card, other photo ID

20 points – previous four rent receipts, recent pay advice

10 points – vehicle registration certificate , utility accounts, rates notice, health care card, pension card

Proof of Income

You will be required to submit proof of your income with your application. Your application will not be processed unless this is provided.

- Last 3 pay slips (if employed)
- Bank statements / tax return / accountant letter (if self employed
- Centrelink letter / statement (if not employed)

CONNECTION OF UTILITIES

It is the tenants responsibility to connect all utilities and to arrange disconnection upon vacating. All costs in relation to the connection of utilities are the tenants responsibility unless otherwise stated in the terms of the General Tenancy Agreement.

PAYMENT OF RENT & BOND

In accordance with Place policy, within 24 hours of application approval you will be required to sign the Tenancy Agreement and make payment of the bond amount (equivalent to 4 weeks rent) plus 2 weeks rent.

This office does not accept bond transfers. Bond may be paid by way of money order, bank cheque or direct debit only. If your application is successful, payment of rent can be made by way of BPAY, direct debit, bank cheque or money order. We do not accept cash!
