Proof of Identification (Including photo ID)

- Birth Certificate and/or passport
- Driver's license
- Medicare card
- Identification/Student card

Rental History

- Two previous rental receipts (if direct deposit, please provide a copy of your bank statement)
- References from previous landlord/agent
- A copy of the lease agreement
- Tenancy ledger (This can be obtained from your current managing agent)
 If you do not have rental history (ie. You have previously owned a property), please provide us with proof of your ownership such as council rates.

Proof of Residential Address

- Phone, water, electricity or gas bill
- Current motor vehicle registration papers

Proof of income

- Two previous pay slips or written reference from your employer confirming you position, salary and duration of service with the company
