TENANCY APPLICATION FORM

- If you are a current home owner and have never rented before, proof of ownership must be provided i.e. a copy of your rates notice.
- If you are over the age of 18 and will be residing at the property, but do not wish to be on the lease, you must still fill out the application form to be an approved occupant.

The property will remain on the market until a lease has been signed and initial rent and bond have been received.

If your application is successful:

You will need to sign the lease within 24 hours, or at another time agreed by both parties.

At the time of the sign up you must also have your Bond and two weeks rent up front or proof of a completed bank transfer.. We do <u>NOT</u> accept any payments via cash or cheque, bank transfer only.

If your application is not successful:

You will be notified by phone or email and your application form will be destroyed.
