The following items MUST be provided:

- Copy of photo ID (Driver's license, proof of age card of passport).
- 2x Current pay slips **or** Letter of Employment/Centrelink benefit/Bank Statement (showing proof of income). If you are self-employed, please provide your accountants details or a copy of your latest tax assessment.
- If you are a home owner and never rented previously you must provide a copy of your most recent Rates Notice.

Please note:

- To avoid delays please ensure the application form is FULLY completed and all abovementioned items are supplied. Applications will not be processed until all information is submitted and the application is signed (highlighted areas).
- Applications will also not be processed unless an internal inspection of the property has been carried out.
- Applications will normally take up to 2 business days to process.
- A successful applicant will be required to pay full bond (4 weeks rent) and sign the lease within 24 hours of approval. Two weeks rent is to be paid before the keys are handed over. All relevant parties must be present at the time of signing the lease. Leases can be emailed upon request.
- The property will remain on the market until a lease has been signed and initial rent and bond have been received.
- Owners are not required to give a reason for why an application has been unsuccessful.
- This office is a member of TICA (Tenancy Default Database).
