

# **IDENTITY CHECK**

When making an application to lease a property with Borrelli Quirk Newcastle Real Estate Pty Ltd, you must provide us with copies of identification so we can verify your identity. The point system we use is similar to those used in financial institutions. Proof of income and photo ID is mandatory in all cases.

Application will **NOT BE ACCEPTED** until all documents have been provided.

A tenant ledger MUST be provided if you are currently renting with a Real Estate agent

Driver's License or another form of Photo ID

Passport and/or Visa (if not Australian resident)

Proof of Income (pay slips, Centrelink statement or letter from employer. Bank statements DO NOT count)

Previous Tenancy Rental Ledger

**Current Bank Statement** 

Council Rates (if you are a home owner)

A Reservation Fee equal to one week's rent will only be accepted on approval from the landlord. This fee will only reserve the property for the agreed period and you will forfeit this payment, should you decide not to proceed or if the holding period is exceeded. This payment must be paid within 24 hours of approval.

#### If your application is successful, the following is required upon signing of the lease:

Initial payments will only be accepted in the form of Credit Card Payment, Direct Transfer, a money order or Bank cheque (NOT a personal cheque) these are to be made out to Joe Borrelli Real Estate Pty Ltd as the payee

- > 2 weeks rent in advance. Rent can be paid fortnightly or monthly (if requested by the tenant)
- > Rental bond (4 weeks rent). The bond will be lodged by the tenant with The Rental Bond Board
- > Rent can be paid either by direct deposit, cheque, bank cheque or money order
- > CASH WILL NOT BE ACCEPTED UNDER ANY CIRCUMSTANCES.

All applications are subject to landlord approval. If your application is unsuccessful, we will endeavour to notify you as soon as possible, however a reason will not be provided and your application will be destroyed to protect your privacy.
